Given that Party A is a professional supplier of auto parts, and Party B purchases auto parts products from Party A, both parties have reached the following agreement regarding product warranty and quality assurance after friendly negotiation:

I. Product Details

1. The products covered by this Agreement encompass all auto parts purchased by Party B from Party A. The specific product names, models, quantities, and dates of purchase shall be subject to the formal purchase orders or sales contracts confirmed by both parties.

II. Warranty Period and Conditions

1. **Warranty Period:** Party A promises to provide warranty service for product failures resulting from manufacturing defects within **one (1) year** from the date of purchase by Party B or up to **30,000 kilometers** of product usage, whichever comes first.
2. **Scope of Warranty:** The scope of warranty is strictly limited to manufacturing defects and quality issues inherent to the product itself.
3. **Exclusions (Non-Warranty Coverage):** The warranty does not cover issues arising from, including but not limited to:
 - Improper installation, misuse, abuse, or neglect;
 - Unauthorized modifications, alterations, or repairs to the product;
 - Accidents, collisions, off-road usage, or external force causes;
 - Normal wear and tear.

III. Warranty Service Process

1. **Failure Confirmation:** Party B shall promptly notify Party A upon discovering any product failure covered by this warranty and provide necessary supporting evidence (e.g., clear photos, videos, maintenance records, diagnostic reports). Party A reserves the right to inspect and evaluate the faulty product to determine whether it falls within the warranty scope.
2. **Repair or Replacement:** If Party A confirms that the fault falls within the warranty scope, Party A will be responsible for repairing or replacing the defective products free of charge (at Party A's discretion). If repairing or replacing with the same model is not feasible, Party A shall compensate Party B for the corresponding commercial value of the goods.

3. **Freight Charges:** During the warranty period, if a return or replacement is caused by verified product quality defects, round-trip shipping costs shall be borne by Party A. If the return or exchange is not due to product quality issues, all associated freight and shipping costs shall be borne by Party B.

IV. Other Terms & Provisions

- 1. **Confidentiality:** Both parties shall maintain strict confidentiality regarding the terms of this Agreement and any commercial or technical secrets disclosed during the execution of this Agreement.
- 2. **Dispute Resolution:** Any dispute arising from the implementation or interpretation of this Agreement shall first be resolved through friendly consultation between both parties. If consultation fails, the dispute may be submitted to the International Chamber of Commerce (ICC) for arbitration in accordance with its rules.
- 3. **Effectiveness:** This Agreement enters into force upon being duly signed and stamped by both parties, and its validity period aligns with the warranty period of the relevant products. This Agreement is executed in duplicate, with each party holding one copy, both having equal legal validity.
